**1. Discussion and Approval of Student Services Council Meeting Minutes, November 27, 2012, and December 18, 2012**

**2. Review of the Governance Constitution – ‘Draft’**

**3. Student Action Policy**

Michelle McCrillis discussed the following with the student members present:

- **Under 7.0 Procedures:**

- 7.4 Persons who are not members of the College Community are not entitled to participate in these activities on College property.**

- (A suggestion was made to change the wording from participate to initiate. However, following more discussion, the consensus of the Committee Members was to add the underlined shown below:

- Persons who are not members of the College Community are not entitled to participate in these activities on College property, but may participate in them at the discretion of the College.**

- Joseph Kroell suggested that the Quinsigamond Community College campus be included in protests with other colleges.

- Joseph Kroell made a motion to table the **Student Action Policy** to the next meeting. Michelle McCrillis asked the students to discuss the **Student Action Policy** with the Student Senate and to bring their comments and suggestions to the next meeting.

**Additional Comments:**

- Michelle McCrillis announced that the Acting Vice President of Enrollment and Student Services would serve as an Ex-Officio Member of the Student Services Council.
- Michelle McCrillis asked if the Committee would like a presence from the Office of Public Safety, or perhaps extend an invitation to the Nursing Faculty and other Divisions.
- A list of individuals could be submitted to the Governance Review Team as elections are scheduled to take place in April. Judy Colson suggested that a process be developed for recommending those people willing to serve on the Committees.
- Ralph Parente made a motion to keep the membership as stated at the present time. Jane Shea seconded the motion. The motion was unanimously agreed upon.
